

National Information Standards Organization Open Discovery Initiative Update Winter 2021

Dear Colleagues,

NISO's **Open Discovery Initiative** provides technical recommendations for the exchange of data in order to provide a way of assessing content providers' participation in discovery services and to ensure fair and unbiased indexing and linking. The updated **ODI Recommended Practice** provides a more detailed treatment of Abstracting and Indexing (A&I) content products, and supports better metadata sharing (including information about open access material) and record display, as well as improved tracking of usage statistics and authentication mechanisms. It also includes advice on systems, training, and communication for libraries that configure and upgrade their discovery systems.
